Description of Activity:

We performed a full count of 105,513 bars of gold, based upon the gold inventory as at 30th June 2010, between 5th July and 22nd October 2010 at the Custodian's premises and performed certain procedures including but not limited to the following:

- The gold inventory records of Bank of New York Mellon (the "Trustee") were reconciled to the records of the Custodian.
- Each individual gold bar in the gold count was agreed to the records of the Custodian as being held in the name of the above mentioned account. The bar number, refiner brand and purity of each bar were checked against the records of the Custodian.
- A statistically random sample of the gold bars counted were weighed and the weight checked against the Custodian's records.
- The records of the Custodian at 30th June 2010 were reconciled to the records of the Custodian at 22nd October 2010 being the last day of the gold count.
